# Managing Leachate Seeps Below Final Cover


Leachate seeping out of landfill slopes is a common occurrence at landfills. Landfill operators struggle to address leachate seeps and manage liquids reaching the landfill boundary. During the dry season, leachate seeps are normally more manageable, and less effort must be spent by the operator to control liquids on the surface; however, during the wet season with frequent storm events and high precipitation in Florida, landfill operators constantly work on the slope trying to stop seeps or devise means to control liquids reaching the surface.

Generally, after closure of a portion of the landfill slope, the issue of leachate seeps that was problematic and bothersome prior to the closure is completely forgotten because leachate seeps are no longer visible. The assumption is that the seeps automatically disappear because the closure prevents rainwater from entering into the landfill. This assumption may be true if the source of water leading to the seep is in the closed area; but if the source is in a different area (i.e., an area that is not yet closed) the seep underneath the final cover geomembrane continues for a much longer period of time until the actual source is covered by geomembrane at a later date.

To manage leachate seeps below the final cover geomembrane, the author developed a leachate toe drain system (LTDS). The first LTDS was designed and permitted in 2001, and implemented in 2002 at an extremely wet landfill located in south Florida. Severe leachate seeps from slopes had previously caused significant problems for a closed portion of the landfill slope and caused potential compliance issues for the facility operator. It was very obvious that the source of the seeps was the large open top area of the landfill that was going to remain open for a long time. Prior to construction, the author modified the final cover design to incorporate

the LTDS for collection and disposal of liquids flowing down the slope underneath the cover geomembrane. The LTDS was designed to be connected to the nearby leachate collection pipe cleanouts and/or nearby primary system riser from the sump. These connections conveyed the collected liquids in the LTDS to the leachate collection system for removal through the leachate collection sumps. The success of the project was the reason for including a LTDS in all future final cover designs by the author.

The LTDS is simply a collection and removal system constructed below the final cover geomembrane at the



perimeter of the landfill. The system involves a short-length geocomposite (LTDS geocomposite) over the lower portion of the slope, and a perforated pipe encased in gravel and wrapped in geotextile (LTDS burrito) at the perimeter berm within the lined area of the footprint. The burrito is placed inside a depression near the top of the lined slope of the perimeter berm, but below the anchor trench shoulder. The depression is created near the top of the slope within the protective cover sand. The end of the LTDS geocomposite is placed at the bottom of the depression and the LTDS burrito is constructed directly above the LTDS geocomposite inside the depression. The LTDS geocomposite is anchored on the slope approximately 10 to 15 ft vertical distance above the perimeter berm. After installation, the cover geomembrane comes in contact with the LTDS geocomposite,

and the geocomposite becomes the sole conduit for liquids below the cover geomembrane flowing to the bottom of the slope. Since the LTDS geocomposite provides a preferential path for the flow of liquids, the liquids directly flow through the geocomposite to the LTDS burrito instead of entering soils at the bottom of the slope where by it would have created a soft and saturated condition at the toe of the slope below the cover geomembrane. The perforated pipe in the LTDS burrito is connected to a cleanout pipe or a specifically designed piping system to convey liquids to a nearby leachate collection sump.

If specific leachate seep locations are identified on the slope above the LTDS geocomposite boundary, the seep locations are surveyed prior to disturbing the slope for construction of the final cover. After the slope was prepared and before installation of the cover geomembrane, the surveyed locations are staked for identification on the prepared slope and the LTDS geocomposite panel directly below each seep location is extended up the slope to cover the seep location and is anchored above the seep. The

extended geocomposite panel provides a preferential path for liquids coming out of the seep underneath the cover geomembrane to the LTDS burrito. Even if the seep remains active for many years after closure of the slope, the LTDS geocomposite will continue directing liquids coming out of the seep to the LTDS at the toe of the landfill slope for collection and disposal.

The author has been involved in construction of numerous partial closures at very to relatively wet landfills and the LTDS included in the closure system has proven to be an important component for keeping the final cover intact and stable on the slope. Since 2002, author's clients have adopted the LTDS feature as a standard component of their landfills' final cover systems. Typically, the cost of the LTDS is approximately \$27 to \$35 per lineal foot.

### Assessing Our Department's Financial Health -A Recent Tipping Fee and Assessment Cost of Service Study

#### Charlotte

County was one of the first communities in the state to implement a non ad valorem, special assessment to fund solid waste management operations. Over the past 30 years, this program has expanded well beyond solid waste disposal by inclusion of solid waste collection and recycling services within the overall customer special assessment. Not unlike other communities statewide Charlotte

communities statewide, Charlotte has been faced in recent years with responding to issues of reduced waste tonnages to its landfill and greatly reduced operational budgets.

In light of these issues, an extensive capital improvements plan, and a possible change in franchise collection operations within the next five years, County managers wanted a fresh look at the Department's cost

Cost of Solid Waste Service Planning Steps Using both historical and current Department budget information from its six cost centers, a Pro Forma financial model (Model) was developed, which enabled development of projections of revenue needs of solid waste collection, recycling, and disposal for the upcoming planning period (FY 2014-2018) as well as to model different possible rate structures.

> of service to help analyze long-term financial health. A final report was submitted to the Board of County Commissioners in July as part of the overall County budget process. This article provides a brief summary of the study, which should be of interest of other communities and agencies statewide facing similar financial issues.

> Briefly, the overall objective of a cost of service and rate study design study is to determine the solid waste

fees and assessments required to adequately recover the costs of providing those services to the customers. Based on its solid waste industry experience, SCS worked with County through a series of eight critical tasks (Exhibit 1) that provided a foundation for the conduct of the Study.

In accordance with Florida state law, the solid waste assessment rate developed in this study would be assessed as a non-ad valorem special assessment for solid waste within the Charlotte Sanitation Unit. Therefore, the

customer classes included in this rate analysis include the following: Unincorporated Charlotte County, Don Pedro and Knight Islands, and Boca Grande.

Three different options were developed for consideration by the BOCC:

• Option 1, "No Change Option" – This option assumes that the estimated deficits in anticipated revenues would




Exhibit 2. Revenue Requirement by Cost Center

be met by using existing available
funds in the Department's reserves.
Option 2, "Full Recovery Option" – This option assumed a full recovery of estimated landfill revenue needs.
Option 2, "CPL Adjustment Option"

• Option 3, "CPI Adjustment Option" – This option assumed that an annual estimated 2 percent CPI adjustment would be made in the landfill tipping fee for a partial recovery of the estimated landfill revenue needs.

In discussions with the BOCC, it was believed that the Department's adequate fund reserves at this time could be utilized over the next three years to cover any potential shortfalls in landfill tipping fee revenues and solid waste collection assessments. The current contract with the County's franchise hauler includes a provision for stable collection and recycling rates during this time period. The Pro Forma Model will be used by the County to estimate potential escalation costs when the County enters into contract renegotiation in three years. Exhibits 3 and 4 graphically illustrate a comparison of the proposed assessment and tipping fee rates with those of neighboring communities.


