## What Role Does Planning and Policy Development Have in Your Community?





#### Why Are Formal Plans and Policies So Critical?

- Plans and associated policies and goals help to capture intentions, establish a roadmap towards progress, and ensure accountability
- Plans can help align community goals with state, national, and international goals
- Adopted plans are useful in framing discussions with the public and elected officials
- Adopted plans can help support new programs and initiatives
- Formal plans can help strengthen grant applications
- Plans provide continuity as elected officials and staff change over time



## Updating Solid Waste Element of the Comp Plan

- Last updated in 2008
- Primarily focused on disposal
- Capacity challenges and increased population growth
- A need to re-examine the long-term approach to waste management
- Comprehensive Plan update provides a framework for sustainable solid waste policy





### Hillsborough's Solid Waste Update Background



- Language developed collaboratively with Solid Waste Department, Planning Commission, and Innovation and Resiliency Section
- Sets long range policy for sustainable solid waste management:
  - Provides framework for reducing waste generation and maximizing waste diversion from County operations
  - Explores new opportunities for beneficial use of waste
  - Policy direction to guide programmatic enhancements and capital projects



#### Stakeholder and Public Engagement

- Formal announcements, newsletter articles, project webpage, reference documents and virtual public outreach conducted April-June 2021
- Also targeted solid waste industry stakeholders, neighborhood and community associations, environmental organizations, agriculture, and the building/development community
- Received input from Planning Commission and Board of County Commissioners





#### New Solid Waste Chapter Summary

- Shift from a disposal focused plan to one centered on the integrated hierarchy of waste management
- County as a leader both in practices and by example
- Expanded policy language on waste reduction, reuse, and recycling
- Emphasis on leveraging waste as a resource and energy recovery
- Increased focus on coordination, partnerships and collaboration

#### **Waste Reduction**

**Reduce** - minimize the amount of waste produced by not generating it in the first place

**Reuse** - reuse, repair, and repurpose items over and over again to avoid disposal

Recycle/Compost - transform waste into new beneficial products to avoid disposal and environmental extraction

Energy Recovery - convert non-recyclable waste into usable energy

> Disposal - safely dispose of waste in landfills



### Comp Plan Key Policy - Highlights

- 1.1.2 Support state and federal efforts to establish producer responsibility systems (e.g. product redesigns) in reducing waste generation at the source and end of life management of materials; explore methods to enhance local producer responsibility.
- 1.1.3 Expand partnerships with the public, private and nonprofit sector to enhance community reuse opportunities and increase organics recovery and composting infrastructure.
- 1.1.4 Pursuant to state statutes, require new commercial and multi-family developments to provide adequate space and receptacles for recycling infrastructure.
- 1.1.5 Explore a phased approach to universal recycling to expand recycling to all commercial and multi-family properties.
- 1.1.6 Explore and support approaches to increase waste diversion from construction-related activities.
- 1.2.2 Implement policies and programs to recover organics from the waste stream for beneficial use.
- 1.3.1 Continue education and outreach to support citizen awareness regarding waste reduction strategies such as composting, reducing contamination in recycling and utilizing reusable materials.
- 1.3.7 Continue collaboration with regional partners on solid waste projects and programs.



## Policy Win!- Requiring Recycling Infrastructure with New Commercial Development

- THE LANGUAGE YOU USE MATTERS!
  - Comp Plan Policy 1.1.5- Explore a phased approach to universal recycling to expand recycling to all commercial and multi-family properties.
- Sec. 6.03.15 of Site Development Plan Design Standards for Dumpster and Recycling Collection Space
  - "All new construction of commercial or industrial uses, and multifamily residential developments that do not receive curbside service, shall provide sufficient, on-site space for the placement and servicing of solid waste containers required for trash disposal and at least one container for recyclable materials collection."



#### Developing a Sustainability Action Plan


- Off shoot of the County's pursuit of LEED for Cities & Communities certification process
- Process led by another department but provided an opportunity
- Generally aligns with United Nations Sustainable Development Goals
- Nearly all departments actively participated, some more than others
- Accelerated collaboration with internal and external stakeholders

### County's Solid Waste Master Plan

#### **Master Plan Goals**

Maintain predictable solid waste rates that cover the cost of service

Minimize landfill disposal

Maximize efficiency, productivity, and useful life of the RRF

Decrease contamination in curbside recycling by 5% by 2020

Collaborate with other jurisdictions within the County to increase recycling and diversion

Increase recycling within the commercial and multi-family sectors in the service area.

- Developed in FY14-15 with a 20 year horizon
- More narrowly focused on Solid Waste Department goals and needs
  - Analyzed trends, tonnage projections, facilities, financial considerations
- Used to help guide internal departmental decisions
- Was not formally adopted by Board of County Commissioners
- County intends to start the update process soon.



#### Closing Tips on Leveraging Planning Efforts

- The planning process itself can be valuable in identifying stakeholders and partners within and outside of your organization that can help advance your policy goals.
- Be sure to utilize other planning efforts within your community to advance your goals even if you aren't driving the process.
- Having plans formally adopted by your elected officials adds value, longevity, and strength.
- Use adopted plans as a touch stone to review new programs, initiatives, grant applications, proposals, etc.
